

TERMS AND CONDITIONS OF USE FOR USERS

Idiomas Tec, whose legal nature is 2135 – Entrepreneur (Individual), registered with the CNPJ under nº 41.750.051/0001-18, with headquarters in the State of São Paulo, in the City of São Paulo, at Estrada das Lágrimas, nº 3.621, São João Clímaco, CEP 04244-000, is a legal entity under private law responsible for the **Biblical Hebrew** application.

Through these General Terms and Conditions of Use (Terms), Idiomas Tec presents to users (Users) the essential conditions for the use of the services offered in the application.

By using the **Biblical Hebrew** application, Users accept and submit to the conditions of these Terms and the Privacy Policies.

1. Definitions

1.1. For the purposes of this document, the following definitions and descriptions should be considered for your better understanding:

Cloud Computing: or cloud computing, is a service virtualization technology built from the interconnection of more than one server, through a common information network (e.g. the Internet), with the aim of reducing costs and increasing availability of sustained services. Access Account: login and password to access the **Biblical Hebrew** application and its features, created using personal information provided by the User.

Content: any and all text, graphics, images, music, audio, video, information or other materials made available in the application, regardless of whether it is User Content, Partner Content or Biblical Hebrew application Content.

Content of the Biblical Hebrew application: any and all content that Idiomas Tec makes available through the **Biblical Hebrew** application, including any content licensed from third parties, but excluding User Content.

User Content: any and all content that a User posts, transfers, publishes, submits or transmits to be made available in the application stores in which the **Biblical Hebrew** application is marketed.

Link: Internet address terminology.

Platform: virtual mobile application stores for downloading and installing the **Biblical Hebrew** application.

Services: refers to any and all services provided by Idiomas Tec through the Platform.

Payment System: system used by Idiomas Tec in partnership with the Platform that provides the download, installation and subscription of the **Biblical Hebrew** application, enabling the contracting and payment of plans offered through the Platform. The interested User must register their credit card details on the Platform to use this service.

User: natural person, fully capable in accordance with the Civil Code, able to contract the Services offered through the Platform.

2. Object

2.1. The services covered by these Terms consist of:

2.2. Biblical Hebrew is an application for teaching the Hebrew language used in writing the Old Testament. It was created to help Theology students and Christians interested in reading and understanding biblical texts in Hebrew.

2.3. Biblical Hebrew activities can be accessed on the application for mobile devices available (cell phones) on the Platforms.

2.4. Idiomias Tec is solely responsible for the veracity and accuracy of the content of its Services advertised on the Platform.

2.5. All payments and transfers of amounts must be made solely through the means provided by the Platforms for downloading, installing and subscribing to the **Biblical Hebrew** application.

2.6. When registering, the User has access to some free activities available in the application and, to have access to all activities, they need to subscribe to one of the plans offered in the **Biblical Hebrew** application – monthly, semi-annual and annual – declaring, to do so, that they have read, understood and accepted the Terms.

3. Registration

3.1. Anyone can register and carry out the free activities available on the application. However, to access paid activities, that is, those available only to subscribers, the User must follow the paid subscription guidelines available on the Platform.

3.2. Registration can be carried out directly in the application, by filling in the personal data requested by Idiomias Tec.

3.3. Idiomias Tec reserves the right to refuse any registration request and to cancel a previously accepted registration, at its sole discretion and without prior notice, with no compensation or compensation for cancellation of any registrations or impossibility of registration.

3.4. When creating an account on the **Biblical Hebrew** app, the User is responsible and obligated to provide only true, accurate and authentic information and to keep it updated while using the **Biblical Hebrew** app. **Biblical Hebrew** Users guarantee and respond, in any case, civilly and/or criminally, for the veracity, accuracy and authenticity of the registered Personal Data.

3.5. Idiomias Tec is not responsible for the veracity, accuracy, authenticity or updating of User data.

3.6. The User undertakes to notify Idiomias Tec, through the contact channels maintained by the **Biblical Hebrew** app on the Platform, regarding any suspicion or finding of unauthorized use of their account. The User will be solely responsible for the operations carried out on their account, as access will only be possible through the use of a verification system that is exclusive to their account.

3.7. Under no circumstances will the assignment, sale, rental or other form of transfer of the account be permitted. The creation of new registrations by people whose original registrations have been canceled due to infractions of Idiomias Tec's policies will also not be permitted.

4. Payment Methods

4.1. Payment for subscriptions, to access paid activities, will be made by Credit Card through the Platforms (Virtual Stores).

4.1.2. When opting for one of the subscription types – monthly, semi-annual or annual – the User must be aware that the renewal of their subscription is automatic. The User may, at any time, cancel their subscription. In order to avoid future recurring charges, it is the User's exclusive duty to cancel sufficiently in advance so that the amounts are not posted to their credit card statement.

4.2. Subscription types and payment methods are available on the Platforms: App Store and Play Store.

5. Discounts and Promotions

5.1. Idiomas Tec may, at its free and exclusive discretion, offer discounts to its Users. By accepting these Terms, Users are aware that discounts and/or promotions:

- a) may be limited to a certain number of Users or a specific period, to be informed in advance by Idiomas Tec;
- b) can only be used through the **Biblical Hebrew** application and via credit card payment;
- c) will have defined rules to be made available on the Platform and/or other communication channels between User and Idiomas Tec.

5.2. Users will not be refunded money and/or will not be entitled to other discounts and/or promotions if:

- a) at the time of purchasing the discount and/or promotion, the User is informed that the limit on the number of users or specific period of discount and/or promotion has been exceeded;
- b) there is a problem, which is not the sole fault of Idiomas Tec, at the time of payment;
- c) any systemic problems occur and/or with the respective credit card operator, the fault of which is not exclusive to Idiomas Tec.

6. User Responsibilities

6.1. The User is responsible and undertakes to:

- a) recognize that all accesses made to the **Biblical Hebrew** application are interpreted as having been made by the user in an indisputable manner, and any form of sharing of login and password for strangers to access the application's content is prohibited;
- b) have devices, resources and technological equipment with enabled antivirus and firewall, duly updated software, in addition to adopting minimum security measures for access to the **Biblical Hebrew** application.

6.2. The features of the **Biblical Hebrew** application are offered in the form of a service, not granting the User any rights over the software or the IT structures that support it.

7. Service Cancellation Policy

7.1. The User who wishes may request the cancellation of their subscription contracted directly through the Platform, sufficiently in advance so that the amounts are not posted on future invoices.

8. User Subscription Cancellation Policy

8.1. Idiomas Tec may terminate these Terms, User Accounts or Users' access to the **Biblical Hebrew** application at any time, without prior notice or consent and at its sole discretion. The User may cancel their subscription to **Biblical Hebrew** on the Platform itself, as long as they do not have any outstanding obligations in relation to Idiomas Tec.

9. Exemptions and limitations of liability of Idiomas Tec

9.1. Idiomas Tec respects and obeys all laws and regulations applicable to its activities and expects all its Users to do the same. However, Idiomas Tec cannot guarantee and assumes no responsibility for the compliance of its Users with any laws or regulations. By using the **Biblical Hebrew** application, the User declares that he or she is aware, understands and agrees that he or she is solely and fully responsible for complying with any and all laws, rules, regulations and legal and tax obligations that may apply to the use of the application **Biblical Hebrew**.

9.2. Users acknowledge and agree that:

- a) Idiomias Tec will not be responsible for errors and/or inconsistencies in the provision of information when registering the User in the **Biblical Hebrew** application;
- b) Idiomias Tec does not directly manage payments made by its Users and does not store their bank or credit card details, using, for greater security, services offered by the Platform (App Store or Play Store) on which the **Biblical Hebrew** app. Idiomias Tec does not assume any responsibility for errors, setbacks or losses resulting from the use of these services, including, but not limited to, loss of values, excess charges, delays in confirming payments or disclosing data on the use of these services, registration, banking or confidential information provided during transactions;
- c) Idiomias Tec is not responsible for fraud, nor for any damage caused by the action of third-party fraudsters who, through shady means, steal Users' bank details and/or credit card details or any other form of payment. Nor is it responsible for viruses, Trojans, malware or any other malicious program installed on the User's computer, tablet, cell phone, mobile device or browser to obtain Users' banking details and/or credit card details or any other form of payment;
- d) payments made by Users may be canceled at any time by the credit card operator or financial institution, and the cause of said cancellation will not be disclosed by Idiomias Tec, for reasons of banking secrecy. In these cases, Users must, if they deem it necessary, contact the financial institution and/or credit card operator with which they have a legal relationship;
- e) Idiomias Tec will not be liable for any damage or loss caused to your cell phone(s), computer(s) or any other electronic equipment, as a result of accessing and using the Platform;
- f) Idiomias Tec is not responsible for any damage, loss and/or loss suffered by the User due to failures in their internet connection, with their provider, in the operating system or server used by the User, resulting from the conduct of third parties, unforeseeable circumstances or force majeure;
- g) Idiomias Tec will not be responsible for any virus, trojan, malware, spyware or any software that may damage, change settings or infiltrate the User's equipment as a result of accessing, using or browsing the internet, or even as a consequence of the transfer of any data and information.

10. Intellectual Property

10.1. The commercial use of the expression "**Biblical Hebrew**" as a trademark, business name or domain name, as well as the logos, brands, insignia, layout of **Biblical Hebrew**, content of screens relating to **Biblical Hebrew** teaching activities are proprietary of Idiomias Tec and are protected by laws and international treaties on copyright, trademarks, patents, models and industrial designs. Improper use and total or partial reproduction of said contents are prohibited, except with express authorization from Idiomias Tec.

10.2. Any intrusion, attempt, or activity that violates or contravenes intellectual property rights laws and/or the prohibitions stipulated in these Terms of Use will make the person responsible subject to the relevant legal actions, as well as the sanctions provided for herein, and will also be responsible for compensation. for any damage caused.

11. Seals

11.1. Any attempt, direct or indirect, successful or not, to carry out any of the activities listed below is prohibited. The confirmation of such an intention will make the author, as well as his principals, defenders, encouragers and helpers, subject to the sanctions provided for in these Terms, the relevant legal actions and the responsibility to compensate any affected parties for any damages caused. Such activities include, but are not limited to:

a) bother, attack, slander, insult, defame, persecute or harass any other User of the

Biblical Hebrew;

b) infringe the rights of any person or entity, including, without limitation, intellectual property, privacy, publicity or contractual rights;

c) copy, store, or in any way access any information contained on the Platform or in the Services or Content for purposes not expressly authorized by these Terms;

d) use the Platform or Services to transmit, distribute, publish or send any information relating to any other person or entity, including, without limitation, photographs of other people without their permission, personal contact or credit information, telephone number or account numbers;

e) manipulate the prices of the Services or any other information contained in the advertisements, in the Platform or Services;

f) use the Platform or Services for any commercial or other purposes that are not expressly authorized by these Terms;

g) use manual or automated software, devices, robot scripts, or other means or processes to access, "scrape," "crawl," or "spider" any part of the **Biblical Hebrew** Services or Content;

h) modify, copy, distribute, transmit, display, perform, reproduce, publish, license, create derivative works, display on another web page, use on any other website, transfer or sell any information, software, user lists, database or other lists, products or services provided by or obtained by Biblical Hebrew, including, but not limited to, practices involving "screen scraping", "database scraping", or any other activity for the purpose of obtaining lists of users or other information;

i) use automated scripts to collect information or otherwise interact with the **Biblical Hebrew** Platform or Services;

j) access, test, tamper with, interfere with or damage the Platform or any **Biblical Hebrew** or User system through the use of viruses, cancel bots, Trojan horses, harmful codes, flood pings, denial of service attacks, packet or IP spoofing, forged routing or electronic address information or similar methods or technology;

k) attempt to detect, scan, or test the vulnerability of any **Biblical Hebrew** system or network or breach any security or authentication measures;

l) forge any TCP/IP packet header or any part of the header information in any posting, email or newsgroup, or in any way use **Biblical Hebrew** Services or Content to send altered, misleading or false identifying source information;

m) attempt to decipher, decompile, disassemble or reverse engineer **Biblical Hebrew** Services or Content.

12. Sanctions

12.1. If any User fails to comply with any provision of these Terms and other Idiomias Tec Policies or does something that harms the Platform, the **Biblical Hebrew** application or the Users, Idiomias Tec may, at its sole discretion, at any time and without notice or prior consent:

a) suspend or permanently cancel the User's Account and any and all access by such User to the **Biblical Hebrew** Contents and Services.

b) take appropriate actions to investigate and prosecute violations of any nature to the fullest extent of the law, and may involve or cooperate with judicial and police authorities.

13. Applicable Legislation and Jurisdiction

13.1. All items in these Terms are governed by the laws in force in the Federative Republic of Brazil. For all matters relating to the interpretation, compliance or any other question related to these Terms, the parties agree to submit to the São Paulo District Court.
